**OTHER ISSUES:**

1. Chairman observed that some of the CFO subjects that are put up before the committee are without compliance report to CFE conditions and in this regard, he wanted to review the subjects before they were listed and finalized for the committee. Hence, he instructed the Convener to bring the subjects to his notice before dispatching the agenda to its members. **(Action: Convener-CCM).**
2. As of now, BWSSB is charged with the consent fees based on the population of the city considering it as a local body. Committee felt that BWSSB can't be considered as a local body and there is need to change the current method of charging consent fee. Members felt that the consent fees can be charged based on the project cost of the STP instead of population. Hence, SEO-Infrastructure was asked to put up a Board subject on the above in the ensuing Board meeting **(Action: SEO-Infrastructure).**
3. In the new Red, Orange and Green list notified by the CPCB, GOI, Stone crushers are falling under orange category. However, as of now, the CFE/CFO of the stone crusher industries are dealt with at Board office and hence, the same system shall be continued by all the Regional Officers of the Board in future too. An OM shall be issued in this regard by the Corporate cell to all the Regional Officers. **(Action: CEO-1).**
4. The members of the committee noticed that CETPs across the state are not regularly monitored by the Board. It is not known whether the CETPs have adequate facilities to treat the type of effluents they receive from the industries, whether they are receiving preliminarily treated effluents, whether they are able to treat the effluents to the standards stipulated by the Board and whether they are maintaining the database about different aspects of treatment including unit operation details, maintenance of log books, submission of manifests etc. In this regard, members of the committee wanted Sri A Ramesh –SEO (WMC) to inspect all the CETPs and also MSW facilities across the state within next 2 and ½ months time and submit a report to the chairman of the consent committee. **(Action: SEO-WMC)**
