VIII. OTHER DECISIONS:

- 1. Stone Crushers:** Chairman and Board member -Shri Kaveriappa, enquired about the pending issue of OM in respect of stone crusher units to administer CTE and CTO at Head office. CEO-1 informed that it is still pending as the stone crushers is now categorized under orange category and the powers are vested with RSEOs. To make provisions in the XGN is a difficult proposition because only this category is to be demarcated and to be directed to Head office which requires changes in the programming of the XGN software and NIC has informed that such kind of corrections cannot be done. Moreover, he suggested that as the Regional SEO is aware of the local situations, it is desirable that the RSEOs only deal with the consents of stone crushers. But, the Board member-Shri Kaveriappa expressed that for better control, the consents of stone crushers shall be dealt with in the Head office itself. To this, CEO-1 suggested that after the receipt of application by the concerned RO in XGN, hard copy could come to Head office, it could be deliberated in the CCM and based on the concurrence of the CCM, RSEOs can dispose the applications so that there will be completion in the loop. However, the committee could not come to any conclusion on the issue.

2. Regarding obtaining consents by the temporary stone crushers, Chairman wanted to know whether these crushers really close down after their project get over. SEO-Mines, was asked to get report from the Regional Officers on this issue. (Action: SEO-Mines)
3. **Bringing the agenda for 1st authorization and the 1st consent together before the Consent committee:** Regarding this issue, SEO-WMC read out the Rule- 6 of Hazardous and Other Wastes (Management and Trans- boundary Movement) Rules, 2016, the application for 1st authorization shall be accompanied with a copy each of the following documents, namely:-
- (a) consent to establish granted by the State Pollution Control Board under the Water (Prevention and Control of Pollution) Act, 1974 (25 of 1974) and the Air (Prevention and Control of Pollution) Act, 1981 (21 of 1981);
- (b) Consent to operate granted by the State Pollution Control Board under the Water (Prevention and Control of Pollution) Act, 1974 (25 of 1974) and/or Air (Prevention and Control of Pollution) Act, 1981, (21 of 1981);
- And as such, it is not possible to bring the 1st authorization and 1st consent together before the committee, but, it can be streamlined along with the consent renewal.
- However, the Chairman expressed that if the 1st consent is given to the industry, he will immediately start its operations leading to generation of the hazardous waste and if the authorization is not obtained then it will lead to unauthorized handling of hazardous waste by an industry. In this regard, Chairman wanted SEO-WMC to bring it to the notice of the CPCB and suggest amendment in the Rules. (Action: SEO-WMC)
