OTHER DECISION TAKEN:

1. While discussing the subjects pertaining to infrastructure projects, the Chairman felt that the Board should go in for decentralized approach for management of MSW as far as lay outs/apartments are concerned. Hence, he opined that Board should think of insisting the land developers to earmark a portion of land in his lay out for establishment of solid waste processing plant so that the community need not depend on the local authority for the disposal of the solid waste. The extent of land to be reserved by each developer shall be proportional to the area of the lay out and a policy frame work shall be developed by the Board to this effect. SEO-Infrastructure to put up a subject before the ensuing Board meeting on the above issue. **(Action: SEO-Infrastructure)**

2. The members of the committee observed that in most of the cases, industries have applied for the consents and authorizations after the lapse of the validity periods. Hence, it was opined that the names of such industries who have not applied for consents/authorizations sufficiently before the validity dates shall be listed and put up on the KSPCB websites as a deterrent. A circular shall be put up to all Regional Officers on the above informing to provide the list of industries which are repeatedly non-complying and operating without consents/authorizations.(Action: CEO-1)
