**OTHER DECISION TAKEN:**

**1. M/s Lotus power gear Pvt. Ltd., Plot No. 184 and 185, Jakkasandra Industrial Area, Malur Taluk, Kolar:**

In the previous CCM meeting held on 15-02-2016 while discussing with the CFE applications of the above industry, committee had recommended for a visit by RSEO along with the Committee members and report. The Committee member Dr. Jayaprakash Alva informed in the meeting that he has visited the location along with RSEO, Bangalore East and observed that the concerned Regional Officer has given false information in his report. He has not mentioned anything about the construction activities in his report, but, on the field they have started construction activities before obtaining the CFE from the Board. In view of the above, it was resolved to issue notice to the industry to stop the construction activities and also issue a warning notice to the concerned inspecting officer for not submitting the facts. (**Action: SEO-NON EIA OTHER THAN BANGALORE**).

**2. Review of consent fees for the residential apartments and lay outs:** As of now, very meager consent fees are charged while issuing CFE/CFO to apartments and lay outs. This has to be reviewed and as such it was informed to SEO-Infrastructure to bring a Board subject for revision of consent fees based on the project cost/Capital investment. (**Action: SEO-INTRASTATE**).

**3. Coverage of DG sets installed in residential apartments under Air consent network:** As of now, Board is not covering the DG sets installed in the residential apartments. Chairman wanted to go through the logic behind exempting such DG sets and review the decision rather. (**Action: SEO-INTRASTATE**).

4. **Issue of paper notification on filing application for consent three months in advance:** Members of the consent committee noticed that the issue of consents to the industries and other establishments are getting delayed because of the time taken to scrutinize the applications at various levels. During this period, the organizations are made to operate without any legal back up. To avoid this, it was decided to issue a paper notification in leading newspapers informing all the stake holders to apply for consent renewal three months in advance of the lapse of validity period. (Action: CEO-1).
