I. Read & confirmation of proceedings of previous meeting:

The proceedings of the previous meeting held on 10.12.2015 & 21.12.2015 were read and confirmed with the following modifications.

- M/s Mahaganapathi Stone Crusher, Sy No. 329, Yeralapadi Village, Udupi Taluk and Dist:**
The subject on disposal of consent applications in respect of the above stone crusher industry was discussed in the consent committee meeting held on 10-12-2015 and the committee had recommended for the issue of consent with conditions. But, in the proceedings, it was left out by oversight. The same was brought to the notice of the Chairman of the Committee and accordingly, incorporated. So, the Committee recommended for the issue of consent to the above said stone crusher for the period up to 30-06-2016 with conditions.
- In the previous committee meeting held on 21-12-2015, issue of CFE for infrastructure projects (within Bengaluru City) was discussed and a decision was taken to issue the CFE to infrastructure projects (Non – EIA projects) within Bengaluru City in view of the submission of the report by the expert committee to the Hon'ble Green Tribunal and also for project attracting EIA after the issue of E.C. by SEIAA.

However, the same issue was discussed in this meeting once again. The decision was deliberated again with respect to the NGT judgment. The Chairman opined that as the present status of the case is under adjudication, legal opinion from legal experts is required before grant of CFE

irrespective of E.C. accorded by SEIAA. Hence, decision taken on 21-12-2015, w.r.t the subjects pertaining to Infrastructure cell coming within Bengaluru city limit (BBMP) were reviewed and resolved to keep on hold until the legal opinion is received.
