### Preamble:

Every person who desirous for recycling or reprocessing the hazardous waste specified in Schedule I, II & IV of the Hazardous Waste (MH&TM) Rules 2008 as amended up to 2010 & recycling & dismantling of E-waste specified in Schedule I of the E-waste (M&H) Rules, 2011 shall make an application in form XIII and Form-I under Water( Prevention & Control of Pollution)Act, 1974 and Air( Prevention & Control of Pollution)Act, 1981 for Consent for Establishment (CFE), Consent for Operation (CFO) and Form-I under E-waste (Management & Handling) Rules, 2011 & Hazardous Waste (MH & TM) Rules, 2008 amended up to 2010 for authorization.

In order to ensure recyclers more responsible and to comply with the rules prescribed, the Board in its 184<sup>th</sup> meeting held on 17-07-2012 has resolved to collect guarantee money of Rs. 1.00 Lakh from the E-waste recyclers & dismantlers under E-waste (Management & Handling) Rules, 2011 & Hazardous Waste Recyclers under Hazardous Waste (MH & TM) Rules, 2008 amended up to 2010 as matter of security for implementation of control equipments & other necessary systems stipulated by the Board.

Hence, the following orders

### ORDER

In order to ensure, the rules prescribed under the E-waste (Management & Handling) Rules, 2011& Hazardous Waste (MH & TM) Rules, 2008 amended up to 2010 are complied effectively by the applicants, a Guarantee Money of Rs. 1.00 Lakh shall be collected before issue of CFE to the E-waste recyclers & dismantlers of Schedule I & Hazardous waste recyclers of Schedule I, II & IV.
