## **TERMS & CONDITIONS OF TENDER SALE OF SCRAPPED VEHICLES**

### **1.0. GENERAL:**

- 1.1 Scrapped Vehicles as per the schedules attached are available for sale by Tender. The bidder shall quote their highest rate for each Vehicle separately exclusive of applicable taxes for which bid is offered. **Scrapped vehicles will not be registered by Regional Transport Offices.**
- 1.2 The intending Bidder has to bid through e-Portal of GoK only by paying Tender fee as per e- procurement portal. The date of Tender indicated in the Tender Notification.
- 1.3 The Vehicle indicated in the notification is tentative and are liable for variation. No claim in this regard shall be entertained by the Board.
- 1.4 All the bidders should read all the conditions of Tender sale notification, carefully before participating in bidding.
- 1.5 The bidder shall submit the declaration duly signed for having read the Tender Auction conditions.
- 1.6 The bid shall be kept valid for a minimum period of 180 days from the date of Tender.
- 1.7 KSPCB reserves the right to accept /reject any bids and also withdraw any Vehicles from the bid without assigning any reasons and or notice. In such a case, the bidders have no right to claim any compensation.
- 1.8 KSPCB employees are barred both from participating in the bid and having any pecuniary interest in the sale.
- 1.9 Right to accept/reject any bid and also with the any Vehicle from the bid without assigning any reason and/ or notice rest with KSPCB.

### **2.0 Earnest Money Deposit clause:**

- 2.1 EMD paid by the H1 & H2 bidders will be held till the approval of the bid by competent authority. The EMD, thus held will be adjusted while releasing the scrap Vehicles consignment/ Vehicles allotted to successful bidder and EMD of H2 bidder and returned only after H1 bidder lift the scrap Vehicles. The highest bidder will be intimated about the confirmation/acceptance of his offer after the approval of the bid by competent authority.
- 2.2 EMD amount as detailed in schedule of Vehicles shall be paid online through e-Procurement Portal of GOK using any of the following payment modes:
  - 1) Credit card
  - 2) Direct debit
  - 3) National Electronic Fund Transfer (NEFT)

- 4) Over the counter OTC (Only Through designated branches of ICICI Bank)
  
- 2.3 Bidders may note the fact that their registrations with any other authority do not entitle them for exemptions from payment of EMD.
- 2.4 The bids of the bidder who does not furnish the details prescribed in the Annexure are liable for rejection.
- 2.5 The EMD of the bidder is liable to be forfeited under the following cases;
  - a) If he withdraws from bidding or fails to lift the Vehicles within the given period.
  - b) If he revises any of the terms quoted during the validity period.

- 1.5 The Intending bidder may submit bids for one or more item along with requisite EMD for each item separately.

### 5.0 Other terms & conditions:

5.1 Before participation in Tender the bidder shall go through the terms and conditions in details and abide by them. The decision of KSPCB shall be final and binding on the bidder. ## 7.0 ACCEPTANCE

## 8.0 REFUND OF EMD

EMD paid will be returned to un-successful bidders on finalization within 30 days from the last date of open Tender whichever is later. EMD of first & second highest bidders will be held by KSPCB.

## 9.0 PAYMENT:

- 9.1 After opening of Tender, Committee will declare the names of the successful highest bidders considering Tender. For such items where the offered rates by the highest bidders are not acceptable, the Tender Committee may conduct negotiations with the highest bidders and 2<sup>nd</sup> highest bidder.
- 9.2 The successful bidder will be informed in writing in due course and he has to remit 100% value of bid (including EMD) for Vehicles plus taxes and levies within one month from the date of receipt of allotment letter/communication. If he fails to remit the amount within the stipulated period, the EMD furnished by him for the item shall be forfeited.
